## STEPS TO MAKING A WILL





#### 1. MAKE A LIST OF YOUR ASSETS

Your assets include things such as property, shares, savings and other items of value you own. Together, these assets are known as your 'estate'.

#### 2. CALCULATE WHAT YOU OWE

Consider things such as an outstanding mortgages or loans, as this will give you a clear idea of the value of your estate.



# 3. DECIDE WHO WILL BE YOUR BENEFICIARIES.

Decide which organisations you'd like to support in your Will, and how much you'd like to leave to each.



A Will executor is the person who will carry out the terms of your Will, to make sure your wishes are fulfilled as you specify. Executors are often solicitors and trusted family members.



# 5. KEEP YOUR WILL SAFE AND UPDATED

To make sure your Will is kept safely, it might be easier to leave it in the care of your solicitor and keep your own copy in a safe place that your executors know where to find.

## **RESIDUARY GIFT**

A residuary gift is a share of your remaining estate, once all other debts have been paid. This is a great way to leave a gift in your Will, as it will keep its intended value over time.

## **PECUNIARY GIFT**

A pecuniary gift is a fixed amount of money that you leave in your Will. It is a good idea to review pecuniary gifts regularly, as their value can be lessened over time.

## A SPECIFIC GIFT

A specific gift is when you leave a particular item of value – such as personal possessions, property or shares.
